#### Changes

#### Time

Officiant will arrive 10 minutes before the contracted time. If ceremony is delayed and there is no other ceremony after yours, officiant will wait up to 20 min after scheduled ceremony. If ceremony is delayed after 20 min, Officiant has the right to leave or charge an additional time fee of \$40 per 15 min. If there is another ceremony scheduled after your wedding, the officiant has the right to leave without notice in the case that the ceremony is delayed after contracted time.
